

## REGULATIONS OF THE “PIGGY BANK” PROMOTIONAL CAMPAIGN

### Article 1

#### Campaign Period

1. The “Piggy Bank” Promotional Campaign, hereinafter referred to as the Campaign, begins on 02 July 2026 and will take place simultaneously at Casino Estoril and Casino Lisboa.
2. The Campaign is organised by Estoril-Sol (III), S.A., the concessionaire for the operation of games of chance in the permanent gaming zone of Estoril, which, in that capacity, operates both Casinos referred to in paragraph 1.
3. The Campaign shall end on the date publicly announced by Estoril-Sol (III), S.A. through its usual communication channels, namely in person at Casino Estoril and Casino Lisboa, and on the websites [www.casino-estoril.pt](http://www.casino-estoril.pt) and [www.casino-lisboa.pt](http://www.casino-lisboa.pt).

### Article 2

#### Campaign Mechanics

1. This Campaign is open to persons over 18 years of age who meet the legal requirements for access to the gaming areas at Casino Estoril or Casino Lisboa, possess a complete registration to access such areas, are enrolled in the loyalty programme, and have authorised the receipt of Marketing communications via SMS and/or email.
2. In order to participate, the persons referred to in paragraph 1 must possess a dedicated booklet, to be provided at the Loyalty Desk of Casino Estoril or Casino Lisboa. This booklet will be used for the campaign mechanism described in the following paragraphs of this Article.
3. Depending on the number of points accumulated in their player account during a gaming session, participants shall be entitled to collect stamps in the booklet, up to a maximum of 2 stamps per session, as follows:
  - a) 10 to 29 points accumulated in the player account: 1 stamp
  - b) 30 or more points accumulated in the player account: 2 stamps.
4. The maximum number of stamps that may be obtained in a single gaming session is 2, even if the participant accumulates more than 30 points in that session, regardless of any points exceeding that threshold. For the purposes of this Campaign, a “gaming session” shall mean the daily operating period of Casino Estoril and Casino Lisboa, beginning in the afternoon of one day and ending in the early hours of the following day.
5. At the moment points are accumulated in the player account, a participant may not yet possess a booklet. In such cases, the points obtained during the gaming session in which the participant requests the booklet shall entitle them to stamps, provided one of the requirements referred to in paragraph 3 is met, and such stamps shall be granted at the time the booklet is requested.
6. Each participant may only have one active booklet at a time. However, participants may continue collecting benefits associated with the campaign mechanism once a booklet has been completed.

Such benefits shall be recorded in the subsequent booklet, to be provided at the location referred to in paragraph 2.

7. Once all benefits in a booklet have been collected, the participant must return it at the location referred to in paragraph 2, even if the booklet is not fully completed. In such case, a new booklet shall be issued to the participant.

### Article 3

#### Benefits

1. The benefits granted under this Campaign consist of promotional tickets, to be used for gaming on slot machines and not redeemable for cash (hereinafter referred to as “promotickets”), to be awarded in accordance with the following paragraphs of this Article.
2. Depending on the number of stamps collected in the booklet, participants shall be entitled to the following benefits:
  - a) 5 stamps: 10€ (ten euros) in promotickets;
  - b) 10 stamps: 20€ (twenty euros) in promotickets;
  - c) 15 stamps: 30€ (thirty euros) in promotickets;
  - d) 20 stamps: 60€ (sixty euros) in promotickets.
2. The promotickets referred to in the preceding paragraph shall be valid for 60 days.
3. Participants are responsible for maintaining the booklets used in the Campaign and the promotickets referred to in the preceding paragraphs in good condition, so that they may collect the benefits recorded in the booklet and use the promotickets during their respective validity period. Estoril-Sol disclaims any responsibility and shall have no obligation to replace booklets or promotickets issued under this Campaign in the event of loss, misplacement, illegibility, or irreparable damage.

### Article 4

#### Irregularities

1. The following shall be deemed irregularities, resulting in the immediate forfeiture of all benefits referred to in Article 3:
  - a) Participation or attempted participation by a person who does not meet the requirements set out in Article 2;
  - b) The provision of false, inaccurate, or incomplete identification data;
  - c) Tampering with, falsification of, or alteration to the booklet intended for participation in the Campaign;

- d) Obtaining or attempting to obtain stamps in a participant's booklet using points accumulated by another person;
  - e) Use or attempted use of a booklet belonging to another participant.
2. In addition to the provisions of paragraph 1, the provision of false, incorrect, or inaccurate information, as well as the submission of irregular identification documents for registration purposes, may also subject the offender to the legal sanctions provided for by law.

#### Article 5 Final Provisions

1. Estoril-Sol (III), S.A. reserves the right, at any time, to cancel this Campaign and any associated benefits.
2. Any omissions and doubts concerning the interpretation of these Regulations shall be decided by the Casino Management, in accordance with the applicable legislation, with the right of appeal to the Gaming Regulation and Inspection Service.
